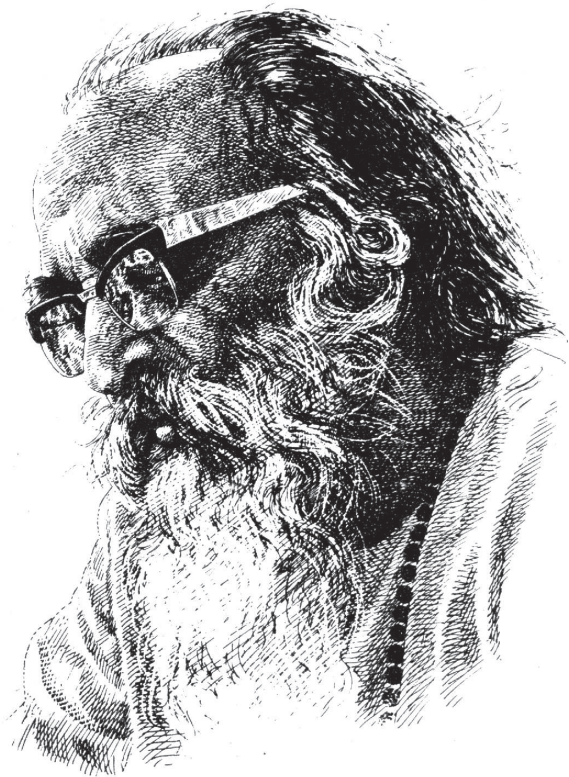

### 5.1 Chinmaya Eswar Gurukula (CEG)

#### 5.1.1 Adi Sankara Niyalam - Veliyanad Facility

Nestled in the maternal birthplace of Bhagvan Adi Sankaracharya, the Veliyanad facility spans an enchanting ten-acre campus. Surrounded by lush landscapes, serene lily ponds, and sacred temple shrines, this picturesque setting inspires students with its vibrant energy and tranquil ambiance. Conveniently located 47 km from Kochi International Airport and 28 km from Ernakulam South Railway Station, Veliyanad is easily accessible yet blissfully secluded.



#### 5.1.2 Prajna Pratishthanam (PP) - Warriam Road Facility

## 10. Academic System

Chinmaya Vishwa Vidyapeeth (CVV) fosters an academic environment rooted in tradition, innovation, and student-centricity. The academic year at CVV commences with Vidyarambha, a ceremonious initiation into the pursuit of knowledge, followed by the comprehensive Induction Programme, known as the Bridge Programme, providing incoming students with essential insights into the institution's ethos, academic expectations, and to succeed in performing academically at CVV.

Structured into two semesters, the academic calendar offers a diverse array of courses under the Choice Based Credit System (CBCS), empowering students to tailor their educational journey according to their interests, career aspirations, and academic pursuits. This flexible system encourages exploration, interdisciplinary engagement, and critical inquiry, nurturing a culture of intellectual curiosity and creativity among students.

Throughout the academic year, students immerse themselves in a dynamic learning environment guided by experienced faculty members, engaging in a blend of theoretical exploration, practical applications, and experiential learning. The curriculum is designed to cultivate well-rounded individuals capable of thriving in a complex and interconnected world. The pinnacle of the academic journey culminates in the convocation ceremony, where graduates are honored for their academic achievements and personal growth. This grand occasion not only celebrates their success but also

signifies their readiness to embark on new endeavours with confidence, integrity, and a deep-rooted commitment to lifelong learning and service to society.

## 10.1 Vidyarambha

At Chinmaya Vishwa Vidyapeeth, we uphold the cherished tradition of Vidyarambha, a ceremonial initiation into the pursuit of knowledge. Rooted in ancient Indian culture, Vidyarambha symbolises the commencement of learning, marking the beginning of a journey filled with exploration, discovery, and growth. It is a momentous occasion where students, guided by teachers, embark on a path that nurtures intellect, character, and creativity. At our institution, Vidyarambha embodies our commitment to fostering a dynamic and inclusive learning environment, where each individual is encouraged to flourish and excel.

## 10.2 Induction Programme

The student induction programme at Chinmaya Vishwa Vidyapeeth is a two to three-week process designed to ensure a smooth transition into university life. It aims to make students feel comfortable, explore their academic interests and activities, promote bonding, and build character. During the programme, students receive comprehensive information about the university, its rules, regulations, and the various programmes and courses offered. A unique aspect of our induction is the emphasis on the role of Indian Knowledge Systems in contemporary education.

The programme includes a variety of activities such as physical exercises, creative arts, mentoring on universal human values, familiarisation with the university, literary activities, proficiency modules, lectures and workshops by eminent personalities, extra-curricular activities, and feedback sessions. It promotes meaningful interactions among peers, fostering a sense of community and building confidence to tackle upcoming challenges. Mentoring and discussions on universal human values are conducted in small groups with faculty mentors. The programme concludes with feedback from students and a report on their experiences, ensuring they are well-prepared for a successful and enriching experience at Chinmaya Vishwa Vidyapeeth.

## 10.4 Student Management System

Student Management System (SMS) has been specifically designed to cater to the effective monitoring and updating of student credentials. This system includes managing qualifying certificates, generic information, sports, and extra-curricular certifications.

### Accessing the Student Management System

Upon admission, each student will be provided with a unique official email and password. Instructions will be given on how to log in to the various management systems of the University using these credentials. Students will have access to two primary systems:



**1. LMS (Learning Management System):** This is where students will submit assignments and other academic-related submissions as directed by their faculty. (Website: <https://lms.cvv.ac.in/learning> )

**2. SMS (Student Management System):** This system is used for updating administrative records, which need to be maintained by both the student and their parents. (Website: <https://sms.cvv.ac.in>)

### Documents Required for SMS

To ensure smooth processing and verification, the following documents must be uploaded to the SMS:

- A valid Photo ID card (Aadhar card, driver's license, passport, etc.)
- 10th standard/SSLC mark list/certificates
- 12th standard pre-university mark list/certificates
- 12th standard Transfer Certificate (TC) and Conduct Certificate (CC) from the last attended school
- Migration certificate from the examination board
- Caste Certificate (for students belonging to the reserved category) issued by the respective regional village offices
- Medical certificate
- Anti-Ragging affidavit
- Passport size photo
- CVV forms: Hostel undertaking, internship consent, media consent, dress code, CVV Student and Parent Undertaking forms etc.

#### Note:

If a student is unable to submit any document at the time of verification/registration, they must submit an undertaking for the non-submission of documents as provided in the university official website.

### Timeline for Document Submission

Students have specific timeframes within which they must update their information:

**Edit Access:** Students have 30 days from the start of the first semester to upload and edit their documents and generic details.

**Course Registration Edit Access:** For subsequent semesters, students have one week from the start of each semester to register for courses.

**View Access:** Students can view their respective details at any time until the completion or exit from their program.

*Please note that this list of required documents is not exhaustive, and the University reserves the right to modify it as necessary. By adhering to these guidelines, students can ensure their records are up-to-date, which will facilitate a smooth administrative process throughout their academic journey at CVV. For any assistance or further information, please do not hesitate to contact the administrative office.*

## 10.5 Course Registration

At the start of each semester, students must register for their courses via. SMS. While core courses are automatically registered for each student, Minors and Electives

require individual registration. Students have one week from the commencement of the academic session each semester to register for these courses, and failure to do so may result in being barred from attending classes. Guidelines for registration will be sent to the official email provided to each student, and it is the student's responsibility to regularly check for communications from the University. Ensuring timely registration is crucial for a smooth academic experience. For assistance or further information, students should contact the Office of Assistant Registrar-Academics.

## 10.6 Fee Payment

CVV provides an integrated fee payment platform through the Student Management System (SMS). Students can navigate to the 'Fees' section on the left-hand side menu after logging into the SMS and follow the prompts. They will then select the applicable event (e.g., semester fee, exam fee) from a drop-down menu for payment, with all online payment modes accepted. Once the payment is processed, receipts can be immediately printed or downloaded. Additionally, the 'Reports' section allows students to print all paid receipts to date. All students must clear their fee dues before each semester starts. Failure to pay the fee by the cut-off date announced by the University will result in a late fine. Students who do not pay their fees on time will be debarred from attending classes/ not allowed to attend examinations/ have their results withheld until all outstanding fees, including fines, are paid.

## 10.7 Attendance

A student shall be considered to have satisfactory attendance to appear for the examination if he/she attends more than 75% of the working days (inclusive of sick days) for all regular courses, and 90% of the working days for internship-type courses. Leave shall be availed by the students only under unavoidable circumstances. Students must apply for leave beforehand. The leave letter recommended by the Programme Director must be submitted to the Head of the School who will consider grant of the leave. Requests for more than three consecutive days on medical grounds must be supported by a proper medical certificate. Leave granted will not be counted as a physical presence and will not count towards attendance.

All students enrolled for the programmes at CVV will be issued a Biometric Identity Card. Every day while entering the campus, all students are advised to swipe their respective cards in any of the BioMetric scanners anchored at specific locations in the academic block. Attendance will be monitored through the biometric scanners as well as individual roll calls will be conducted during each academic session during normal working hours. All students must register their presence in the academic sessions by swiping their CVV ID cards and it is the sole responsibility of the student to stamp their attendance in the biometric scanner.

**Note:** Condonation of attendance will only be allowed with valid medical certificates.

Students going on official duty, representing the University in sports and cultural activities, or presenting papers at seminars, conferences, etc., may be eligible for Duty Leave.

Any student failing to secure a minimum of 75% attendance in a course will not be eligible to appear for the end-semester examination in that course\*. If a student is not permitted to attend the end-semester examination, of any course, due to shortage





of attendance, he/she shall be awarded an 'FA' (Failed due to lack of Attendance) grade in that course and this shall be mentioned in the grade sheet. Students who are awarded an 'FA' grade in a course must re-register for the course when it is next offered as a run-time re-do course.

*\* For courses that do not have the end semester component, 75% attendance is mandatory to complete the course.*

## 10.8 Choice Based Credit System (CBCS)

All the programmes include common foundation courses (common to all), core courses, core electives, proficiency courses, and self-immersion courses. The courses that students will take while graduating in any major discipline of their choice is categorised into five. Under each category a certain number of courses will be taken by the students eventually leading them to earn a degree. These are briefly explained below:

### For all non-engineering programmes

1. **Major/Core Courses:** Core courses are mandatory for students to develop expertise in their main discipline, preparing them for professional challenges.
2. **Minor Courses (Discipline-Specific):** Discipline-specific minors, including interdisciplinary options, allow students to explore additional subjects. Students can declare a minor by the end of the second semester after sampling various courses.
3. **Multidisciplinary Courses:** Multidisciplinary courses, chosen from unrelated fields, provide broader intellectual experiences and liberal arts education, excluding subjects already studied at the higher secondary level.
4. **Ability Enhancement Courses:** These courses focus on competency in Modern Indian Languages and English, emphasizing language and communication skills, critical reading, and academic writing.
5. **Skill Enhancement Courses:** Aimed at enhancing employability, these courses provide practical skills, hands-on training, and soft skills to boost productivity and competence.
6. **Value Added Courses:** Developed by national experts, VACs aim for holistic personality development and character building, embedding ethical, cultural, and constitutional values, critical thinking, Indian Knowledge Systems, scientific temper, communication, and soft skills.

### For Engineering Programmes

1. **Humanities and Social Science Courses:** Integrate ethics, communication, and societal impacts into engineering education, fostering responsible and informed decision-making.
2. **Basic Science Courses:** Provide foundational knowledge in physics, chemistry, and mathematics essential for engineering problem-solving.
3. **Engineering Science Courses:** Bridge basic sciences and core engineering disciplines, covering key theoretical and practical aspects like materials science and mechanics.

4. **Program Core Courses:** Focus on in-depth knowledge and technical skills within the chosen engineering field, ensuring proficiency in core concepts and applications.
5. **Professional Elective Courses:** Allow specialisation within the engineering discipline, enabling students to tailor their education to career goals and interests.
6. **Open Elective Courses:** Offer interdisciplinary learning opportunities, broadening academic horizons and fostering innovation and creativity.
7. **Audit Courses:** Non-credit courses that enable learning in areas of interest without grade pressure, encouraging lifelong learning.
8. **Seminar/Project/Internship:** Provide hands-on experience and real-world application through research, design, and industry exposure, enhancing practical skills and professional readiness.

## 10.9 University Examination Process

In order to appear for the University examination, the students shall register for the examinations of the courses undertaken in that particular semester as and when notified by the Office of the Controller of Examinations. To be eligible to register for the examinations,

1. Students shall clear all fee dues including any fees to be paid before the registration.
2. Students shall not have any disciplinary issues pending.
3. Students should satisfy the attendance requirements stipulated by the university guidelines.
4. Appear in all internal examinations/mid-semester examinations and submit all course assignments on time.
5. Earn at least 40 % marks for UG courses/50 % marks for the PG courses in the Continuous Internal Assessment (CIA).
6. Pay the exam fee by the due date as notified by the office of the Controller of Examinations.

Based on the eligibility to appear for the exam, the Office of the Controller of Examinations shall enable the link for payment of the examination fees. The students shall remit the examination fees through the link. Any registration beyond the stipulated date will attract a late fee up to three days from the last date of payment of exam fees. Delays beyond this date will deem the student ineligible to appear for the exam.

A student can withdraw from a course in the elective category with the approval of the Head of School through their respective Programme Director. However, this shall be done within seven working days from the commencement of the semester as per the University guidelines.

## 10.10 Student Evaluation and Grading

The student learning process is wholly owned and driven by the appropriate design and execution of evaluation methodology for the course. The University has established a student evaluation framework with the following characteristics:

- The evaluation shall be
  - Based on multiple components.



- Continuous, enabling the students to know the progress on an ongoing basis.
- Encourage student involvement in the learning process both individually and in groups.
- Commensurate to the effort required by the student.
- There shall be timely feedback on performance so that any mid-course corrections are possible.

## 10.11 Evaluation Components—Norms and Guidelines

The University encourages the faculty to use as many components as appropriate (such as from the list including but not limited to those mentioned below) for designing the course evaluation plan. The weightage of each component shall be as mentioned in the respective course outlines.

- Individual submissions including quizzes, assignments, tutorials, worksheets, etc.
- Group submissions including group assignments, projects, seminars, etc.
- Term Paper/Report (final submission at the end of the semester)
- Mid Semester Examination
- University Examination
- Viva Voce/Oral Examination

The schedule of the above-mentioned components shall be announced by the faculty/Office of the Controller of Examinations as the case may be.

## 10.12 Grading System—Marks Equivalence Table

CVV follows the absolute grading system, where marks are converted into grades based on predetermined class intervals. The percentage of marks required to pass a course and the CGPA required to qualify for the award of the degree correspond with UGC recommendations. Accordingly, the following equivalence table is developed for adoption by the Schools and the office of the Controller of Examinations.

### 10.13 Computation of SGPA and CGPA

The UGC recommends the following procedure to compute the Semester Grade Point Average (SGPA) and Cumulative Grade Point Average (CGPA):

The SGPA is the ratio of the sum of the product of the number of credits with the grade points scored by a student in all the courses taken by a student, and the sum of the number of credits of all the courses undergone and earned by a student, i.e.,

$$\text{SGPA} = \Sigma(C_i \times G_i) / \Sigma C_i$$

where ' $C_i$ ' is the number of credits of the  $i^{\text{th}}$  course and ' $G_i$ ' is the grade point scored by the student in the  $i^{\text{th}}$  course.

The CGPA is also calculated in the same manner taking into account all the courses undergone and earned by a student over all the semesters of a programme, i.e.

$$\text{CGPA} = \Sigma(C_i \times GP_i) / \Sigma C_i$$

where  $C_i$  is the credit for  $i^{\text{th}}$  course in any semester, and  $GP_i$  the grade point for the course.

The SGPA and CGPA shall be rounded off to two decimal points and reported in the transcripts.

### 10.14 Academic Dishonesty and Misconduct

Academic dishonesty and misconduct include, but are not limited to, the following:

- **Unfair examination practices:** Unauthorised use of information, materials, devices, sources or practices in completing academic activities.
- **Plagiarism:** Adopting another person's ideas, words, design, art, music, etc., as your own, without acknowledging the source, or, when necessary, not citing after obtaining permission from the author.
- **Fabrication or Falsification:** The unauthorised creation or alteration of information in an academic document or activity.
- **Sabotage:** Disrupting or destroying another person's work so that the other person cannot complete an academic activity successfully.



There are severe penalties (including not allowing students to sit for the examination) for students found guilty of any kind of academic dishonesty and misconduct. All instances of dishonesty including in assignments or examinations, of any magnitude, major or minor, will attract disciplinary action based on the nature and degree of dishonesty.

## 11. Library

The Chinmaya Vishwa Vidyapeeth (CVV) Library stands as a cornerstone of academic excellence, offering an extensive collection that supports the diverse research needs of its students and faculty. With a commitment to fostering an environment conducive to academic inquiry and intellectual growth, the library has meticulously curated a variety of collections and services.

### 11.1 Book Collections

The library boasts an impressive array of reference collections encompassing a broad spectrum of disciplines, including Generalia, Linguistics, Management, Indian History, Economics, Law, Social Science, Engineering, Fine Arts, English Literature, Sanskrit Literature, Bhagavad Gita, Ayurveda, Culture, Psychology, Research Methodology, Advaita Vedanta, Biography, Encyclopaedias, and Dictionaries. Each book is meticulously classified using the Dewey Decimal Classification (DDC) system and catalogued in the **KOHA software**, ensuring a fully barcoded collection that is easily accessible through a web-enabled online OPAC (Online Public Access Catalogue).

### 11.2 Subscriptions and Electronic Resources

The CVV Library subscribes to a multitude of research journals spanning humanities, management, engineering, Sanskrit Indology, and more. It also houses back volumes of several periodicals from various academic institutions and universities. Embracing the digital age, the library offers a wealth of electronic resources, including online databases, e-journals, and periodicals, providing readers with unparalleled access to global research materials.

### 11.3 Facilities and Services

The library is a model of scientific organisation and full automation, providing seamless access to its resources through the KOHA Library automation system. It is equipped with modern amenities such as digitisation facilities, photocopy machines, and dedicated reading rooms designed to enhance the study experience for readers and library members.

## 11.7 Loss/ Damage of Materials

Library materials are to be handled with care. Damage or loss of books on loan should be immediately reported to the librarian in writing. Members are liable to replace such books with a copy of the same/latest edition within one month of its reporting. If not returned within the date specified, members are liable to pay overdue charges fixed for the period up to its reporting in writing from the due date. If the documents could not be replaced; the member shall pay compensation at the following rates:

- For books published before 1990 - 3 times + 20% of the actual cost
- For books published in 1990 or later - 2 times + 20% of the actual cost

## 11.8 Reference Service

The library maintains a separate Reference section. The books from these sections are to be referred to in the library. However, keeping in view the necessity of the faculty, these books may be allowed to be issued for a short period. Important





encyclopaedias, handbooks, data books, dictionaries, and other costly books are available in this section. Special reading facilities for Research Students and faculty are provided in the library. The library has procured educational video cassettes prepared by agencies for self-learning. A viewing facility is available in the library.

The library houses all important reference sources like encyclopaedias, dictionaries, handbooks and manuals, statistics, and yearbooks. The collection ranges from general to subject-specific sources. All the reference sources are housed in the Reference section. Users can also contact staff on duty for any assistance.

## 11.9 Information Literacy/Library Orientation

The library conducts Information Literacy/User Education/Orientation programmes for all at the beginning of the academic year. Besides this, these awareness programmes are conducted when requested by users from time to time.

## 11.10 Other Services

- **Photocopying Services:** The library offers photocopying services for all its readers at a reasonable charge.
- **Display of books:** Books are displayed each day in line with international events or birthdays of renowned scholars
- **Question Papers:** Previous years Question Papers are made available at CVV Library. Only photocopies can be taken.
- **Library OPAC:** Library OPAC can be operated within the campus premises by clicking on <https://opac.cvv.ac.in>. Besides listing all the books and journals available in the library, it allows the facility to know the status of particular books. It is searchable by author, title, account number and several other fields

## 11.11 Library Rules and Regulations

Only registered members are allowed to use the library.

1. Students' membership in the library is renewed at the beginning of each semester.
2. Readers should not right, mark or otherwise disfigure/damage books, furniture etc.
3. Readers are not allowed to bring their personal belongings like bags and umbrellas to the library. These materials are to be kept at the property counter at their own risk. Readers are advised not to leave valuable items like money, credit cards, passport etc. at the properties counter.
4. The library can recall any book even before the due date.
5. Readers have to pay over dues charge @ Rs.5/-per day per book after the due date.
6. Readers should observe strict silence and switch off their mobile phones or keep them in vibration mode while in the library.
7. Drinks and eatables are not allowed in the library.
8. No photograph of the library shall be taken without prior permission from the authority.

9. Members leaving the library should stop at the exit, so that the material borrowed or taken out of the library by them may be checked. Readers are requested to show the documents which are being taken out of the library to the staff at the checkpoints.
10. Members are responsible for any damage caused by them to books or any other property belonging to the library.
11. The librarian reserves the right to suspend the membership of any member found misbehaving, abusing the library staff or behaving indecently.
12. Tables and chairs should not be disturbed from their position. Users should avoid resting their feet on tables, chairs, shelves and windows.
13. Books and the bound volumes of journals should be handled with great care. Please avoid keeping the volume open on the table or inserting notebooks/ pencils between the pages and closing them. Pages must not be folded to serve as bookmarks. Mutilation and disfiguring of pages of library books is strictly prohibited.
14. Users are requested to leave the book on the table after consultation. Please do not replace the book and also do not move the book from its specific area to another area. Library staff will do it for you. **Please remember that a book misplaced is a book lost.**

## 12. Mentoring System at Chinmaya Vishwa Vidyapeeth

The mentoring system practised at CVV is designed meticulously and implemented with the unconditional obligation to ensure that the students are provided with a reliable and comprehensive support system, to motivate them to excel in both academic and non-academic fields. Under the system, a small group of students (mentees) are assigned to a faculty (mentor) who will:

- Monitor the performance and progress of the mentees assigned to the mentor in academics, attendance, extra-academic pursuits and overall development as an individual.
- Provide appropriate counselling to the mentees regarding their academic issues as well as personal concerns.
- Provide suggestions to guide them in their career prospects including but not limited to the setting of career goals, selection of a career path, options for higher education, self-employment opportunities, and entrepreneurship possibilities.

## 13. Training and Placements

CVV is conscious of its commitment to its students in making them shine in their respective knowledge domains, armed with a variety of soft skills that make them fit for deserving placements. Keeping this in mind, CVV has established a full-fledged and highly dynamic Training and Placement Office. The students are trained in an array of areas to:

- Enhance their employability skills
- Empower them with communicative abilities
- Enrich them with leadership qualities



- Enable them to face interviews with ease
- Equip them with life-coping skills
- Enable them to land the right job
- Get the right employer for the right candidate

### **The Training and Placement Office functions with the following objectives:**

- To fulfil the dreams of thousands of parents, by providing their wards with the best career options
- To provide the industry with the best human capital
- To become one of the most industry-favoured institutions in the country for campus recruitment
- To achieve 100% quality placement

Training programmes and workshops are designed and conducted to professionalise students in relation to their studies. CVV takes extra efforts to closely monitor the performance of the students and, if needed, helps to acquire additional employability skills through crash courses in soft skills. The Placement Centre has actively taken up the task of hiring experts from academic and corporate fields to train the students and then place them in leading organisations through campus interviews. We maintain mutually beneficial training and placement tie-ups with various organisations of repute.

## **14. Internship and Dissertation**

### **14.1 Internship**

For the bachelor's and master's programmes, at the end of the second year, students may be required (depending on the programme) to undertake an internship for 8-10 weeks. The Training and Placement Office of the University provides necessary support in arranging suitable assignments. There is a dedicated Internship and Placement Officer for the students to contact regarding any queries and support required. The internship is intended to provide students with an opportunity to apply the principles and methodologies learned and get first-hand experience of the industry with a new perspective. Students may contact the Internship and Placement Officer (Contact details are provided in the Administrative Functionalities list on page 16.)

1. The Internship and Placement Officer makes all efforts to reach out for internships across varied sectors, companies, and profiles.
2. Based on one's interests and capabilities, one should seek internships. Choosing the correct company for internships and performing up to the mark is of utmost importance.
3. Interactions during the internship, both with other interns as well as employees, help students to understand the expectations/needs of the organisation, and the sector in general, identify the gaps in their learning and in orienting themselves towards the sector and developing the required skill sets to emerge as the most suitable candidate.

## 14.2 Dissertation/Project

The dissertation offers an opportunity to explore a topic in-depth of students in their area of special interest. A faculty guide is assigned to each individual/group. The dissertation is carried out under the supervision of faculty member(s) chosen by the University.

1. Students need to choose a dissertation topic in consultation with the assigned faculty.
2. All expenses for this project are borne by the students opting for it.
3. The evaluation parameters include a project report, a presentation etc.

## 15. General Discipline on the Campus

Any act, behaviour, or conduct by a student that adversely affects the general discipline on campus and violates the academic atmosphere, such as inciting hostility, ill will, social disharmony, ragging, bullying, vandalism, destruction of University property, misbehavior with faculty and staff, or any action detrimental to the educational process or reputation of the University, will be treated as misconduct. This includes unlawful acts or public nuisances outside the University, with legal consequences. Misconduct also covers smoking, consumption and distribution of alcohol or intoxicants on campus, willful disobedience of rules, disruption of campus activities, politicising activities, breach of hostel rules, cybercrimes, public display of affection, and unauthorised use of mobile phones and recording equipment in specified areas. Only pure vegetarian food is permitted within University hostels and facilities, with non-vegetarian food, including eggs, strictly prohibited. **Students must review the detailed rules and regulations in the student undertaking form and comply with them to avoid disciplinary action.**

Any form of misconduct will be dealt with severely and may entail penalties ranging up to suspension or expulsion from the programme. All the students are required to strictly adhere to the class timings as prescribed in their respective timetables. Wilful misuse or damage to University property or facilities will lead to disciplinary action/termination of registration of a student/attract charges to pay for the damages, as the case may be. **All enrolled/registered students along with their parents are directed to sign an undertaking provided by the university.**

## 15.1 Dress Code

Students at CVV are to wear the prescribed uniform. Exceptions to wearing the uniform, if any, will be informed in advance by the authorities. No student is permitted to enter any academic or administrative premises in the University without proper uniform. Students are required to wear laboratory/workshop uniforms if prescribed by the department. Until the uniforms are dispersed to the students all are advised to follow the code as given below:

- All are recommended to wear modest and comfortable Indian clothing;
- You may require one or two sets of Indian traditional clothes for special occasions.
- All students must adhere to the designated dress code. Informal or improper dress, which includes sleeveless shirts/blouses, half pants, shorts, tights/revealing clothes, Bermuda shorts, half skirts, or other similar outfits, is not allowed. Any deviation from this standard will be regarded as misconduct and subject to disciplinary action.



- Formal shirts and trousers, casual are permitted for the Boys. Torn jeans, low-waist jeans, cut jeans, shorts, and sleeveless garments are prohibited for Boys.
- Formal/semi-formal dresses, salwar kameez are allowed for Girls. Torn jeans, low-waist jeans, cut jeans, shorts, and sleeveless garments are not allowed for girls.

## 15.2 Disciplinary Authority

The disciplinary authority is the committee convened by the University authorities and the members may change from time to time. The appellate authority on all disciplinary matters is the Vice Chancellor.

## 16. Internet Policy

The internet policy of CVV is governed by the policies framed by the IT department. Access to wireless internet is only an extended service. The availability of wireless services solely depends on the discretion of the University and it has the right to stop/interrupt the services at any given point in time. The University reserves the right to disable one's wireless network access for any of the following reasons if found:

- Allowing other individuals (e.g. friends, co-workers, multiple devices etc.) to use one's account.
- Attempt to tamper/hack the servers/network or overload IT resources and assets by excessive bandwidth usage or using misconfigured devices or knowingly using a false identity.
- Download/usage/storage or transmission of illegal copies of copyright materials or patented software/movies/songs etc. is a violation of the regulatory laws that involve the protection of data or privacy. Violation of this policy and guidelines is a serious offence and the Institution holds the right to permanently seize the laptop/devices and/or initiate strong disciplinary action, including termination from the Institution, if the need arises, based on the severity of non-compliance.

### 16.1 Internet Plan for Students

CVV is regularising the internet usage for students at university campus and the hostel. Students will get the facility as per the following timing and plan.

*\*Once the monthly quota is exhausted students need to take written permission from the respective HOS/HOD and submit to the IT department to renew it again, only one time extension of 30 GB will be allowed per month.*

### 16.2 Misuse of Social Media and Violation of Indian Cyber Laws

Students are cautioned and warned to refrain from the following activities while using any social media platform (such as Facebook, WhatsApp, Twitter, Instagram, Telegram, Snapchat, Viber Messenger etc.) or while sending e-mails or SMS, using CVV identity. .

- Posting any form of anti-national, antisocial or terrorist/communal/racial/threatening messages, etc.
- Sending messages/posts by creating fake IDs and usernames.
- Morphing pictures/photos, forwarding vulgar messages, posting pornographic materials and so on.
- Hacking the electronic accounts of others.
- Stealing and misusing the personal data of others.
- Impersonation through e-mail/SMS/social media i.e. speaking like father/mother/brother etc. of someone else.
- Taking photographs of others without their knowledge and posting them on social media.
- Creating 'groups' and the 'Group Admin' not having any control over the happenings in that group.
- Indulging in 'skimming' of data from credit/debit cards, committing fraud etc.
- Getting involved in prohibited activities such as 'online betting' gambling etc.
- Engaging in any form of cybercrime is against the law and not permitted.

## 17. Norms of Communication

Students are advised to strictly adhere to the following protocols in reporting classroom or academic concerns:

- All students or any other representative of the student body or the student himself may submit their concerns in writing to the Programme Director (PD).
- Students are advised to first contact the concerned faculty for any academic concerns such as notes, cases etc. In case the concerns are not addressed they are required to submit in writing to the Programme Directors and if the concerns are not addressed even after reporting the same to the PDs, it may be subsequently taken up with the Heads of Schools (HoS). If the issues are still not done satisfactorily then a Students Grievance Redressal committee member shall be approached for the same. ( for details of Grievance Redressal cell and complaints, please visit <https://www.cvv.ac.in/grievance-redressal-mechanism>)
- Students are advised to take note that the concerns shall be addressed within 30 days of reporting the same.
- Any violation of the above-mentioned protocols attracts stringent punishments including placement support withdrawal, de-barring etc.

## 18. Security

- Personal property, including money and other valuable items like electronic gadgets, gold, etc., is the responsibility of the student and the institution will not





bear responsibility for items lost or stolen. Items lost or found should be reported to the Chief Security Officer (contact details are provided on the last page) or Facilities Manager within two hours of detecting the loss.

- All students must carry their University identity cards with them at all times.
- While entering the campus all students must enter the credentials in the registration book kept at the main gate security office. Entry and exit is limited to and from the main gate/entrance only.
- Students must carry their ID cards while leaving the campus and leave their phone numbers with the security at the gate along with information about their destination and expected time of return. Students are requested to view this measure not as an intrusion but as a security precaution.
- Day scholars are directed to not stay back on campus or enter the university premises after 5.30 pm. Special permission in writing must be obtained from the HoS/PDs and forwarded to the respective hostel in case of overnight stay shall be sanctioned by the Registrar.
- When a guest comes to meet a student, the student should confirm the same at the University's main gate. This may, at times, require the students to escort his/her guest from the University gate. Only parents and authorised guardians will be allowed to visit the students.
- Students are required to cooperate with the University's security staff.
- Restrict pasting posters or writing on walls and roads inside the campus.
- Avoid indiscipline acts such as indulging in strikes, agitation, group clashes, assaults, use of vulgar language, abuse, causing damage to institution property/misbehavior with faculty, security guards, vigilance staff and others.
- Do not indulge in communal and religious activities.

## 19. Anti-Ragging

The Hon'ble Supreme Court of India, in SLP 24295/2006 dated 16.5.2007 and Civil Appeal No. 887 of 2009 dated 8.5.2009, has defined ragging as 'Any disorderly conduct whether by words, spoken or written, or by an act which has the effect of teasing, treating or handling with rudeness, any student; indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof, in a fresher or a junior student, or asking the students to do any act or perform something which such students will not do in the ordinary course and which has the effect of causing or generating a sense of embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.'

In exercise of the powers conferred by Clause (g) of sub-section (1) of section (26) of the UGC Act 1956, the University Grants Commission has published the 'UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009' in July 2009. The objective of the regulations is to prohibit any conduct by any student or students, ragging in any of the forms as described above; and thereby to eliminate ragging in all its forms.

The UGC vide D.O. letter No.F.1-15/2009 (ARC) pt.-III dated 8 August 2016 has expanded the definition of ragging in the following manner: '3 (j) Any act of physical or mental

abuse (including bullying and exclusion) targeted at another student (fresher or otherwise on the ground of colour, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background.'

According to the UGC vide letter D. O. No. F. 3-2/2021 (ARC) dated 27 October 2021, the UGC has revised the guidelines pertaining to the affidavit to be filled by the prospective students and their parents on the official website – [www.antiragging.in](http://www.antiragging.in).

All students admitted in the University must complete the affidavit thorough UGC website with in 15 days of the the commencement of academic sessions in CVV. ## 20. Hostel Rules and Regulations

At Chinmaya Vishwa Vidyapeeth (CVV), we provide a safe and supportive residential environment that promotes academic and personal growth. Our hostels encourage social and cultural activities, helping students develop well-rounded personalities. Currently, CVV only runs hostels at the LVP Facility in Ernakulam. The Office of the Registrar can create additional rules for hostel management and student behavior outside of class.

### 20.1 Admission & Allotment of rooms

Admission into the hostel is a privilege extended to facilitate peaceful studies on the campus, provided students follow the hostel rules and regulations. Only students of full-time programmes who are currently enrolled at CVV are allowed to stay in the hostels, according to the approved room allotment. Admission for other categories of students will be decided by the University authorities, and the rules may change from time to time. Each resident must submit a duly filled hostel admission form at the time of admission and at the beginning of every academic year. Room allotment will be based on availability and preferences, with the final decision resting with the University authorities. Mutual exchange of rooms is not permitted. However, in exceptional cases involving serious health or medical issues, the Office of the Registrar, upon recommendation from the Hostel Warden(s), may consider a written request supported by convincing documents for a room change.

The allotment of rooms and fees applicable are published on CVV website <https://www.cvv.ac.in/notifications>

### 20.2 Withdrawal

Students should not vacate the hostel without permission from the Hostel Warden upon instruction from the Registrar. A 'No Dues Certificate' must be submitted to the Office of the Registrar before leaving the hostels. Students who book hostel accommodation and pay the hostel admission fee at the beginning of the academic year are required to commit to a one-year residency. No refunds will be issued if the student withdraws before the completion of the committed one-year period.

### 20.3 General Discipline\*

- Attend all academic sessions punctually; avoid staying in hostel rooms during class hours without permission from the Programme Director. Notify the Faculty Warden and Chief Warden if permission is granted.



- Maintain cleanliness and hygiene in rooms and premises; refrain from disfiguring property by writing or sticking handbills, posters, etc. Students are liable to pay for repairs if any damage is noticed, as decided by the University. Severe penalties, including expulsion, may be imposed for wanton damage.
- Respect fellow residents, hostel staff, and University personnel; follow instructions from hostel wardens and security personnel.
- Behave with decorum, respecting the campus's sanctity, located within a place of great spiritual and cultural importance.
- Unauthorised possession of additional articles apart from provided furniture will result in disciplinary action, fines, and possible confiscation. Also, Do not store prohibited items like high-consumption electrical appliances, weapons, ammunition, explosives, or inflammable materials in rooms.
- Conserve electricity and refrain from tampering with electrical installations; do not fit electrical fittings, heaters, or other appliances in rooms.
- Cooking inside rooms is strictly prohibited and considered serious misconduct.
- Lock rooms properly when going out; the University is not responsible for any loss or damage to belongings.
- Physical or mental harassment, including ragging, quarrelling, abusive language, and violent behavior, is strictly prohibited and will result in strict disciplinary action.
- Motorised two-wheelers and cars are not allowed on campus; only bicycles are permitted.
- Smoking, chewing pan, consuming alcohol, and using any kind of drugs are strictly prohibited. Violation will lead to suspension or expulsion and Possession, consumption, or trading of narcotics will result in immediate expulsion.
- No pets are allowed in the hostel.
- Obtain prior permission from the Chief Warden, Resident Warden, or Programme Director to conduct meetings or make announcements.
- Adhere to the prescribed dress code inside the hostels; do not wear sleeveless dresses, short tops, tights, Bermudas, or shorts outside your room.
- Multi-level marketing (MLM) and gambling, including playing cards, are prohibited.
- Anti-institutional or anti-social activities are severely punishable.
- Adhere to the hostel and mess timings.
- Be present in assigned rooms for daily attendance verification at 9:00 p.m. Absence without prior written approval from the warden will result in strict disciplinary actions.
- Obtain prior permission for overnight stays outside the hostel.
- Day-scholars, alumni, or outsiders are not allowed inside the hostel premises.
- Food delivery must be handled by the hostel warden.
- Obtain a gate pass from the resident warden to leave the campus.

\*Please review the rules and regulations outlined in the Hostel Guideline and Enrolment form for more detailed information. Compliance with these regulations is mandatory; failure to adhere to them may result in disciplinary action for misconduct.

## 20.4 Holidays/Vacation

- Every student must vacate his/her room before proceeding on summer vacation and surrender the room to the administrative staff/Hostel Warden. If any room is found locked, the hostel authorities have the right to break open the same and the cost of damages will be accounted to the respective student.
- Personal belongings of the students proceeding on vacation may be left behind in their respective rooms till they return. All such articles must be packed, properly labelled and entrusted to the Hostel Wardens for safe custody in the rooms earmarked for this purpose.
- While every effort will be made to see that the articles are kept safely, the hostel authorities are not responsible for any loss or damage caused. Students are therefore advised not to leave behind any costly items when they go on vacation. The University reserves the right to allocate any room for any academic activity or undertake repair and maintenance work during holidays/vacations.
- The room is to be vacated by the student after the completion of their respective programmes within two weeks after the last exam/final year/semester/trimester unless the hostel authorities give a specific date for the same. All students are required to clear their hostel dues, penal charges, recoveries on loss or damage caused etc., to be eligible to be issued a 'No Dues Certificate' required for receiving the completion certificates and Degree/Diploma certifications.
- The Office of the Registrar may consider applications from residents for staying in the hostels during a vacation on charges as notified by the University if their vacation academic activity (such as summer placements) requires them to be stationed.

## 20.5 Guest Rules and Guidelines

- No student is allowed to bring a guest into the hostel for an overnight stay with him/her except under exceptional circumstances where a parent or a sibling is to be accommodated on a special occasion with prior written request and approval from the Office of the Registrar. If any family member is required to stay overnight with the student, the student must seek and obtain prior explicit formal permission from the Office of the Registrar. Any failure in this shall be treated as serious misconduct.
- Other than an overnight stay in such circumstances, the stay of an outsider in the hostel is not permitted.
- The Office of the Registrar has the power to refuse permission to allow guests into the hostel, without assigning any reason.
- The guests, if any, permitted are subject to the rules and regulations of the hostel.
- The hostel maintains a register of guests and no guest is admitted, irrespective of the permission granted by the Office of the Registrar unless the name and other



particulars are entered in the register. The student who brings the guest will be responsible for the proper filling up of the particulars required therein.

- The student introducing a guest is responsible for all charges incurred by the guest. The University will notify the guest of charges including rentals from time to time.

## 20.6 Tradesmen/Vendors

No strangers are allowed in the hostel premises for carrying out any business. Students shall not have dealings with strangers other than licensed tradesmen/vendors on the campus. In case any stranger is seen on the hostel premises, students must immediately inform their respective Hostel Warden/Chief Security Officer.

Food delivery partners like Swiggy, Zomato etc. are strictly prohibited inside the university campus.

## 20.7 Annakshetra Rules and Regulations

- The residents of the hostel shall, from amongst themselves, elect a suitable number of representatives who will form the Mess Committee. The student committee shall be in charge of running the mess and the maintenance of hostel amenities. If at any time there are no elected representatives, the University authorities shall have the power to make necessary arrangements to run the mess directly, or by nominated representatives, until representatives are duly selected.
- Consumption and Serving of Non-Vegetarian food is prohibited in CVV Annakshetra.
- Meals or any food item will not be sent to students' rooms.
- A sick diet can be provided to the members under the advice of the Hostel Warden. For this, specific requests may be submitted to the Office of the Registrar.
- Under no circumstances are the students allowed to take cups, saucers, tumblers, and other utensils of the mess to their rooms or other locations. Any violation of this norm will attract stringent action.
- Students are expected to maintain strict discipline and order in the dining halls during the hours when meals are served. Students must be suitably attired in the dining hall (suitable attire, in this case, refers to any dress covering the body appropriately. Half pants, shorts, Bermuda, half-skirts etc. are not permitted in the mess or any other academic premises). No resident, except the representatives, shall enter the kitchen.
