Course Description

This is a core course prescribed for the first semester B.A. B.Ed. students. The course covers the initial history of English literature. It traces the lineage of English literature and British history.

Course Introduction

The course introduces the beginnings of English literature. Familiarising the students with the history of the Old and the Middle Ages in England, the course presents an understanding of the development of English literature along with its social and cultural milieu. The course aims to aid students in tracing the early English poetry, folktales, legends and its evolution in the due course.

Course Objective

- 1. To introduce students to the British history and how it contributed to the development of Old and Middle English.
- 2. To introduce the students to the foundations of English Language and Literature focusing on its emergence, evolution and progress through different ages and

3. To enable the students to identify the key moments and events in the literary history of England during these periods.

- 2. Analyse and evaluate the historical, social and cultural contexts of the Old and middle English age.
- 3. Understand the major texts of the Old and middle age and thereby, critically appreciate them.
